


The Committee examined the Grievances received from M/s M. H Pharma Jail Road, Lahore. The Grievance Committee also granted the opportunity of personal hearing to the representatives of the firms on 29.11.2022. The attendance of the Committee members and the representative of firm who appeared during hearing is enclosed. The Grievance Committee after due deliberation at length in light of PPRA Rules and Bidding Documents concluded the following decisions:-

1	M/s MH Pharma Copper-T	Non Compliance of knock Down Criteria Clause 1 <u>Clause 1:</u> In case of medical device, copy of Medical Device import license & Medical Devices Enlistment certificate issued by DRAP	Firms stated that, "we have attached enlistment application submitted in DRAP for enlistment of TCu 380A (IUCD Cooper-T 380 A) of M/s SMB Corporation of India in favor of M/s MH Pharma. The board of DRAP referred enlistment case to authority for approval due to product & import from India. After Approval of authority the Board approved item in this enlistment board meeting of Drug Regulatory Authority of Pakistan (DRAP). Now, we have got the enlistment/registration certificate of our applied Medical Device item IUCD Copper T (TCu 380A) from DRAP. It is requested that please consider our valid Enlistment Certificate issued by DRAP and prequalify in this item"	The Grievance Committee examined the Grievance filed by the firm and observed that the firm has applied for the enlistment to Drug Regulatory Authority of Pakistan. Further, the representative of the firm stated that the matter was pending with DRAP and now the certificate has been issued to firm by DRAP which is available for the perusal of the committee. Decision: The Grievance Committee unanimously accepted the Grievance of the firm and prequalify the firm.
