
The Technical Committee examined the documents & samples of said Syringes. Injection filling practically done by the Committee. The evaluation report of the Technical Committee is given below:-


S.#	Name of Bidder	Remarks
1.	M/s MH Pharma, Lahore	Not approved due to deficient filling of injection as per requirement of the dosage.
2.	M/s Amson Vaccine & Pharma, Pvt. Islamabad	Approved, as according to the specification and filling requirement
3.	M/s SY'AH Impex, Karachi	Not approved, as not according to the specification
4.	M/s Hospital Services & Sales, Karachi	Not approved due to deficient filling of injection as per requirement of the dosage.
5.	M/s Advance Tech, Lahore	Disqualified due to non compliance of Compulsory Parameters and the sample is also not according to the specifications


