**AN
ORDINANCE**

to amend the Transfer of Population Welfare Programme (Field Activities) Ordinance, 1983

WHEREAS it is expedient further to amend the Transfer of Population Welfare Programme (Field Activities) Ordinance, 1983 (XIX of 1983), for the purposes hereinafter appearing;

AND WHEREAS the President is satisfied that circumstances exist which render it necessary to take immediate action;

NOW, THEREFORE, in pursuance of the Proclamation of Emergency of the fourteenth day of October, 1999, and the Provisional Constitution Order No.1 of 1999, read with the Provisional Constitution (Amendment) Order No.9 of 1999, and in exercise of all powers enabling him in that behalf, the President of the Islamic Republic of Pakistan is pleased to make and promulgate the following Ordinance:—

1. Short title and commencement.— (1) This Ordinance may be called the Transfer of Population Welfare Programme (Field Activities) (Amendment) Ordinance, 2001.

(2) It shall come into force at once.

2. Amendment of section 7, Ordinance XIX of 1983.— In the Transfer of Population Welfare Programme (Field Activities) Ordinance, 1983 (XIX of 1983), hereinafter referred to as the said Ordinance, in section 7, for the words “such other activities of the Programme as it may specify to be field activities” the words “or withdraw from such Governments any activities of the Population Welfare Programme as it may deem necessary to improve the execution of the Population Welfare Programme” shall be substituted and shall be deemed always to have been so substituted.

3. Amendment of section 8, Ordinance XIX of 1983.— In the said Ordinance, in section 8,—

(1) in sub-section (2), after the word “Ordinance”, at the end, the words and commas “and shall, notwithstanding anything contained in any other law for the time being in force or any judgment of any Court or tribunal, including a High Court and the Supreme Court, be deemed to have become the civil servants of the respective Provincial Governments on such commencement and shall be governed by the rules and regulations made under the Provincial laws relating to civil servants” shall be added and shall be deemed always to have been so added; and

(2) after sub-section (4) the following new sub-section shall be added, namely:

—

“(5) Notwithstanding any judgment of any Court or tribunal, including a High Court, the Supreme Court, any law, contract, agreement or in the condition of service, all actions taken, powers, including financial and administrative, exercised, orders or instructions issued, by the Federal Government and Provincial Governments in respect of terms and conditions of employees referred to in sub-section (1) after their retention in the Federal Government or transfer to the Provincial Governments, shall be deemed always to have been validly taken, exercised or issued by the Federal Government and Provincial Governments”.
