Tender Documents containing terms & conditions and detailed specifications and quantity of required syringes can be obtained on payment of Rs.500/- per item (Non-refundable being the tender Cost) from the Procurement & Logistic cell of Directorate General, Population Welfare Department, 14- Babar Block, New Garden Town, Lahore on any working day during office hours. The tender notice and complete bidding documents are also available for information and downloading on the website of Punjab Procurement Regulatory Authority & Population Welfare Department i.e. [www.ppra.punjab.gov.pk](http://www.ppra.punjab.gov.pk) & [www.pwd.punjab.gov.pk](http://www.pwd.punjab.gov.pk).
2. The interested bidders shall drop their bids (complete in all respects) in the tender box placed in Committee Room of Directorate General, Population Welfare Department, 14-Babar Block, New Garden Town, Lahore at given date & time. Any bid received after specified time will not be entertained. Bid will be opened in Committee Room of the office of Directorate General, Population Welfare Department, 14-Babar Block, New Garden Town, Lahore according to the schedule given above in the presence of bidders or their authorized representatives who choose to be present at the time of opening.
3. The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal.
4. The Procuring agency shall upon request communicate to any bidder, the ground for rejection of all bids or proposals, but shall not be required to justify those grounds.
5. 2% Earnest money of the estimated cost as bid security will be in the shape of call deposit issued in favor of Director General, Population Welfare Department, attached with the Technical bid. Estimated cost is mentioned in bidding document.
6. Procurement shall be governed according the Punjab Procurement Rules 2014.
7. All the items will be supplied in the Provincial Ware House (11-Rahim Farm, Bhubbtian Chowk Lahore) of Population Welfare Department, Punjab, Lahore.
8. **Single Stage –Two envelope procedures (Technical & Financial) as per rule 38 (2)(a) of PPRA Rules, 2014, shall be applied.**
  - i) Tenders should be submitted comprising a single package containing two separate envelopes containing the financial proposal and the technical proposal in separate envelopes.
  - ii) Envelop shall be marked as “**Financial Proposal**” and “**Technical Proposal**” in Bold and legible letters to avoid confusion. The financial proposal envelop will be opened only of those bidders whose technical proposal shall be evaluated as qualified after technically approved as per PPRA Rules, 2014.
  - iii) On rejection of Technical Proposal, the Financial Proposal will be returned unopened. The Department will not be responsible if the Financial Proposal is placed in envelop of technical proposal or found open, not properly sealed, where it is submitted collectively for all the items.
